DESCRIPTION OF SYSTEM USDA is committed to carry out its responsibilities and meet public expectations in enforcing the Animal Welfare Act (AWA) and the Horse Protection Act (HPA) ACIS provides a standard approach to collect, record analyze, maintain, and report information to cooperation and regulatory entities The system will be used to collect and manage customer data for license, registration, facility research, and data gathered from horse shows around the country by the Horse Organization Industries (HOI) and Animal Care (AC) inspectors

Inputs, outputs, and system documentation are covered under the GRS 20, *Electronic Records*, items 2(a) (b), item 6, and 11(a)

This database maintain license, registration, and inspection data including names of business, owner's name, address, telephone number, employee identification number, location of animal, animals used in research, violations, animal inventory, risk assessments, horse shows, and inspection results Horse protection data includes HIO name, horse show name and location, owner, rider, exhibitor or horse violations, and tickets information
