	<p>AGENCY: Grain Inspection, Packers and Stockyards Administration (GIPSA)</p> <p>NAME OF SYSTEM: Laboratory Information Management System (LIMS)</p> <p>UNIT: The Federal Grain Inspection Service (FGIS) was created by Congress in 1976 to manage the national grain inspection system, which was initially established in 1916, and to institute a national grain weighing program. FGIS establishes the Official Standards for Grain, which is used each and every day by sellers and buyers to communicate the type of quality of grain brought and sold. FGIS also establishes standard testing methodologies that accurately and consistently measure grain quality. Finally, the program provides for the impartial application of these grades and standards through a network of Federal, State, and private inspection agencies known as the Official Agencies.</p> <p>DESCRIPTION: LIMS is a computerized laboratory information management system that assists with managing lab data distributed directly to a variety of internal and external users. LIMS automates the collection, processing, quality control, storage of laboratory results data with generated reports or automatic electronic transfer of data to end users.</p> <p>Inputs, output and system documentation are scheduled under the General Records Schedule 20, Electronic Records, items 2, 6, and 11.</p> <p>ITEM 1.
