III-A Tape Files

The 37 II-A files listed below contain 2766 tapes that are no longer required by the Bureau of the Census. 12 of the files are copies of files that the Decennial Census Staff plans to retain in an IBM compatible version; 10 of the files are copies of files that are being retained by the Data User Services Division of Census; and 7 of the files are extracts of files that the Decennial Census Staff will retain. Of the remainder, 6 are base tally files (i.e. initial tallies with unsuppressed data cells made at the lowest level of enumeration [usually block or Enumeration District] from which the summary Census tally files are created) and 2 are PEPOC files (i.e. Post-enumeration Post Office check of persons missed in the Census). PEPOC Tallies x ED" are tally counts. "PEPOC Impute Cold Deck" contains questionnaire responses of a sample of persons missed in the Census. This file has neither personal identifiers nor geographic codes below the region level and was not considered to be representative of those who missed enumeration.
