The file documentation includes a record layout/code book which matches some but not all of the tapes. Some of the final edited microdata tapes were accidentally blanked several years ago so that some of the tapes in this file consist of intermediate data tapes (in lieu of the missing final tapes) whose record layout apparently differs from that in the final documentation.
