Lend-lease accounts related to the Soviet Union, the United Kingdom, and Saudi Arabia. Included in the records are audit worksheets, invoices, bills of lading and manifests for lend-lease cargo placed on specified vessels for the Soviet Union. There are records relating to the Russian Diversion Project and include accounting reports on shipments of lend-lease supplies diverted from the USSR to ports in the United Kingdom. The records also include transaction reports, transfer receipts, statements of reimbursable charges, and invoices. In addition there is routine correspondence between the Department of the Treasury and the Office of Liquidation Commissioners on surplus materials related to British requisitions, and ledgers of statement of accounts with foreign nations. The records reveal an accounting of lend-lease dealings with Saudi Arabia and consist of monthly reports showing the status of lend-lease requisitions, summary reports on the accounting of lend-lease, bills of lading, and charges for ocean transport to the USSR and Saudi Arabia.
