Upon receipt of the Archivist's authorization, the Assistant Administrator for Fisheries, or his designee, will direct each Regional Administrator to establish a cutoff period subject to regional requirements within the 6-75 year retention band.  a. Permits for foreign vessels to fish in the U.S. zone. <b>Disposition</b> Cut off when permit expires or application is rejected. Destroy/delete when between 15 and 75 years old.  b. Permits for U.S. ships to fish in foreign zones. <b>Disposition</b> Cut off at end of calendar year. Destroy/delete after expiration of permit when between 6 and 75 years old.  c.
