**NAME OF SYSTEM:** Physical Examination Records

**DESCRIPTION:** Annual testing candidates required to undergo a physical exam to demonstrate they possess satisfactory physical abilities necessary to perform safely and efficiently the essential tasks of a particular position on at least an annual basis. A waiver of one or more of the physical requirements established by the operating unit and evaluated in the annual test may be granted for applicants and current employees where sufficient evidence exists that they can, with or without reasonable accommodation, perform the essential duties of the position without endangering the health and safety of themselves or others without meeting the particular physical requirement. Specific physical requirements are required as examples of standards for individuals who are to be assigned to rigorous Law Enforcement Officer (LEO) (ZA-1811), criminal investigator
