Additional Schedule Information	The Jefferson Proving Ground (JPG), located in southeastern Indiana, was established in 1940 by the U.S. War Department with the primary mission of testing munitions. It operated under the Test and Evaluation Command from 1941 to 1995. JPG played a crucial role in conducting research, testing, and operations related to various Army ammunition components and ordnance items; however, the testing led to the contamination of soil and groundwater with hazardous chemicals, heavy metals, and unexploded ordnance. In 1996 the Army closed the base and transferred testing operations to the U.S. Army Yuma Proving Grounds in Arizona. JPG is currently administered by the BRAC Division within the U.S. Army's Installation Management Agency which is responsible for managing JPG's closure, cleanup, and property transfer.	

These records document the remediation efforts carried out by the Nuclear Regulatory Commission (NRC), Environmental Protection Agency (EPA), and the US Army Corps of Engineers to decontaminate the area. Efforts involve the removal of contaminated soil and the implementation of groundwater treatment systems. In addition, the collection documents the actions taken by federal officials to communicate with the public and protect the wildlife in the surrounding area. The Army Environment Management System is outlined in Department of the Army regulation 200-1 Environment Production and Enhancement, which sets the framework for environmental management within the Army. This collection supports the National Archives appraisal policy 1441 appendix 2 Environmental Health and Safety Records.

This direct offer applies to a specific set of records currently located at ARMD. The compilation comprises 29 cubic feet (c.f.) of records encompassing a time from 1941 to 1995. The records are stored in standard Federal Records Center boxes. This schedule also applies to similar substantive records if found documenting the Jefferson Proving Ground environmental clean-up.
