

	<p>Ammunition Stockpile Reliability Program AR 702-6</p> <p>Background The Ammunition Stockpile Reliability Program-Firing Data (ASRP FIRING DATA) provides "cradle to grave" responsibilities, to include demilitarization, for monitoring the performance, reliability, and safety characteristics of ammunition items and class V components This program applies to conventional and chemical ammunition, small and large rockets, guided missile ammunition, and associated materiel</p> <p>The ASRP has proven essential for providing the data needed to ensure the readiness of the Army's missiles, rockets, and other ammunitions Missiles, rockets, conventional ammunitions, and other class V items spend nearly all of their life in dormancy but must always be ready for activation Thus an Army program that continually measures stockpile reliability is essential for providing data to ensure that ammunition and ammunition components are available for issue, use and are safe and reliable</p> <p>Note Use record number (RN) 25-1kkk for source/input records, RN 25-111 for automated system administrative reports, RN 25-1mmm for system documentation and specification, and RN 25-1nnn for backup files</p> <p>The proponent is G4</p> <p>RN 702-6a Title Ammunition Stockpile Reliability Program-Firing Data (ASRP Firing Data) System Master File Authority TBD PA TBD</p>
