SUMMARY

The Department of the Army has submitted this Request For Records Disposition Authority adding one new item, 140-111b, Reenlistment Eligibility, in its AR 25-400-2 (MARKS). The records are used in determining reenlistment eligibility of Army Reserve enlisted personnel. Army is seeking a temporary disposition for this item, proposing that the records be destroyed upon reenlistment of the individual. I recommend approval. Similar records created for regular Army reenlistees have the same disposition (see attachment). I have discussed this job with Elaine Everly (NN-E).

RECOMMENDATION

- 1.
