**SUMMARY**

The Department of the Army has submitted this Request For Records Disposition Authority covering records accumulated in its Office of Chief of Army Reserves, and pertains to the life-cycle management of Army Reserve facilities. The records in question consist of blueprints, appropriation requests, construction documents, records of post construction inspections, and routine upkeep and changes. The types of buildings constructed and overseen by this office includes Reserve training centers, maintenance facilities, and equipment construction sites. I recommend approval of Army's request that a temporary disposition be assigned to those records relating to buildings not listed on the National Register of Historic Buildings. Records pertaining to buildings listed on the National Register should, as Army proposes, be approved for permanent retention. The proposed disposition is similar for identical records generated by the regular Army. This schedule should be approved as written.

**RECOMMENDATION**

1. APPROVED FOR DISPOSAL The records described under all items of the schedule, except those that may be listed in blocks 2, 3, and 4 of this section, are disposable because they do not, or will not after the lapse of the period specified, have sufficient administrative, legal, research, or other value to warrant their continued preservation by the Government.
2. APPROVED FOR PERMANENT RETENTION The records described under the following item or items have been appraised by the National Archives and Records Administration (NARA) and are determined to have sufficient historical or other value to warrant their continued preservation by the United States Government. The agency will offer these records to the National Archives as specified
