IPP includes enhancements to an installation's ability to sense, shape, shield, and sustain critical military missions and essential military operations so they may be better prepared to assess, respond to, and recover from CBRN incidents or terrorist attacks. CBRN systems would be selective and, in most cases, transparent to system operators. The system identifies hazardous materials and according to where they are located, how to handle them.</p>
