1.	<p>Disposal of Records Pertaining to Waiver Requests</p> <p>Records generated under the operation of the laws permitting waiver of erroneous payments of pay and allowances, other than travel and transportation allowances, to civilian employees and members of the Uniformed Services. The records consist of Registers of Waivers (4 CFR 92.7), reports of investigation, accounts of the corrective actions taken, accounts of the waiver action taken, and reasons therefor, and other pertinent information such as the action taken upon application for refund.</p> <p>Dispose three (3) years after the end of the fiscal year in which final waiver action is taken, unless sooner notified by the General Accounting Office that an appeal has been filed with that Office, in which case, the three-year period shall begin to run at the end of the fiscal year in which final action on the appeal was taken by the General Accounting Office.</p>
