Background Information **The Nutrition Management Information System (NMIS) is the Military Health System (MHS) / TRICARE Management Activity (TMA) electronic information system for clinical dietetic and food/production/ service information. It contains data elements in the health care records that enable the Military Health System (MHS) personnel to provide preventive and therapeutic medical nutrition therapy (MNT) and medical food management to dietetic MHS beneficiaries and/or their dependents**

SYSTEM INTERFACES Include information received from the Composite Health Care System such as reports from physicians and other medical department personnel (CHCS II (GRS 20 Item 4))

INPUTS Include but are not limited to patient name, sponsor Social Security Number, patient Social Security Number, patient Family Member Prefix (FMP), patient age/date of birth, diet type, manual inputs (notes) from users and patient information received from the Composite Health Care System (CHCS II (GRS 20 Item 2a(4)))

OUTPUTS Include but are not limited to statistical reports regarding inventory, product cost, and patient menus, patient care plans and progress notes (GRS 20 Item 5)
