1. Recent College Graduates:

Public use data files and documentation, 1974-75 through 1985-86 (year of graduation). Restricted use data file of transcripts, 1985-86 (year of graduation) and documentation. Public use and restricted use data files and documentation, 1989- (year of graduation). Data from a national sample of bachelor's and master's degree recipients one year after graduation, with information on education and employment. A transcript file contains data about undergraduate courses, credits, grades and major field of study.

DISPOSITION: PERMANENT. Transfer public use and restricted use data files and documentation to the National Archives upon official release of the file.

2. National Survey of Postsecondary Faculty:

Restricted use and public use data files and documentation, 1987-. Data from faculty, institutions and departmental chairs on issues such as faculty composition, turnover, recruitment, retention and tenure policies.

DISPOSITION: PERMANENT. Transfer restricted use and available public use data files and documentation to the National Archives upon official release of the file.

3. National Postsecondary Student Aid Study (NPSAS):

Public use and restricted use data files and documentation, 1986-. Surveys of samples of all types of postsecondary institutions providing information on how student aid is targeted, received and used. Data provided by institution registrar and financial aid records, parents, and students, both in-school and out-of-school components. Information includes data on loans, family finances, student characteristics, educational activities and employment history, and loan repayment or default.

DISPOSITION: PERMANENT. Transfer public use and restricted use data files and documentation to the National Archives upon official release of the file.
