Item 1. *Federal Register Proposed Regulation Files, 1982.*

Accession Number 441-84-0063, Boxes #1 through 28.

This accession consists of over 15,000 comments received as a result of the publication of a proposed revised regulation pertaining to the education of handicapped children. The records date from 1982, and include comments and regulatory code/tracking sheets.

Disposition: TEMPORARY. Destroy upon approval of this schedule.

Justification: This accession consists of the comments received as a result of the publication of proposed revised regulations in the Federal Register, pertaining to the education of handicapped children program. Included are over 15,000 comments and comment tracking sheets. There is no information in this accession about the changes these comments may have brought about to the final rule, and there is also no information pertaining to the development of the draft regulation. It is also highly unlikely that the Federal Register proposed rule and final rule case files to this regulatory change could still be found at the Department of Education.
