Records assembled in the Office of Director, Division of Nurse Education, as permanent documentation of this program. Letters, memoranda, bulletins, public laws, directives, forms, charts, rosters, telegrams, articles, testimony, reports, photographs, personnel information, minutes, audit reports, tissue carbon reports, press releases, policy papers on Blacks in nurse training programs, fact sheets, and handbooks created and maintained mainly by the Director and her immediate office.

Included are original and entire drafts, or their transcripts of the music scores for the U.S. Cadet Nurse Corps (USCNC) march, USCNC song, "Induction Pledge" by Rolf Baker, and USCNC music for the opening fanfare induction ceremony. Copyright restrictions may apply.

Contains correspondence, applications for funds, proposed curricula, proposed budgets, memoranda, descriptions of nursing programs, forms, course outlines, reading lists, telegrams, notices of encumbrance, annual reports, and audit reports that relate to the application process for federal funding of individual nursing programs during the period before the passage of the Bolton Act.

2. Bolton Act, Program Funding Case Files. 1943-1949. Accession 90-52A0183 Boxes 1-45,74. 20/35:21-5-5 - 20/35:23-7-1 and 20/35:25-3-6. Arranged alphabetically by State or Territory and thereunder by hospital or school of nursing.

Contains memoranda, correspondence, audit reports, follow-up evaluations of individual schools by auditors, financial statements, lists of receipts and expenses, notices of encumbrance, budgetary forms, school applications for admission to the program, school bulletins and catalogues, class schedules, annual reports and telegrams which relate primarily to fiscal matters and involve the funding of undergraduate and postgraduate programs at individual nursing schools.

The cards, Form 300, and reprint versions 300A and 300B, contain abstracted information for each cadet. The abstracted information for each cadet includes dates of birth, admission to school and Corps, and prospective beginning of Senior Cadet period. Also listed are data concerning school of nursing attended, signature, age, home address; signature of the Director of School of Nursing; and reason for termination from program, graduation or withdrawal.

The binders, textual records, document the different mediums used by the Recruitment and Public Relations Section to publicize the accomplishments of the Corps and stimulate new student nurse recruits.
