NDMS mobilizes resources through specialized teams that provide human and veterinary healthcare, mortuary assistance, patient movement coordination, and definitive care during times of need.</p> <p>The National Veterinary Response Team (NVRT) is responsible for the provision of veterinary medical care to ill or injured companion, service, working, and laboratory animals to augment the states' capabilities during public health emergencies caused by natural and technological disasters, acts of terrorism, disease outbreaks, and special events including National Special Security Events, such as presidential inaugurations, and political party national conventions.</p> <p>The NVRT is composed of professional and para-professional veterinary medical personnel, with modular task forces designed to deliver veterinary medical support for resident animals impacted by natural or man-made disasters, animals working in response efforts including National Special Security Events (NSSEs) and to provide guidance and support during incidents that involve infectious agents (zoonotic) or public health threat that may affect human health.</p> <p>Records created before June 29, 2022 are scheduled under DAA-0468-2013-0006.</p>
