	MMLD is an information system that supports merchant mariners who have applied for licenses and documents, are issued certificates of discharge by the marine industry, and tracks the location of archived records MMLD allows the National Maritime Center (NMC) to quickly access merchant mariner personnel files that were previously contained in hard copy personnel files throughout the 17 Regional Exam Centers and at the NMC MMLD maintains information on merchant mariners with a Coast Guard license or merchant mariner's document in the maritime community Specifically, officers, staff officers, operators and documented crew members. The MMLD database contains personnel information which extends from 1937 to present day and contains merchant mariners' names, address, social security number, reference number, "Z" number, cruzenship, telephone, identifying characteristics, license or document activities,				426

- 1. Merchant Seaman's Personnel and Licensing Records. These records consist of Applications for Seaman's Certificates, Seaman's employment history and Certificates of Discharge, which both document the vessels on which they served and dates served, disciplinary record cards, names of next of kin; photos; and ad hoc correspondence related to the Seaman These records also include applications for licenses to hold senior positions (e.g., deck officers, engineers, staff officers, radio officers and pilots). Records include name, home address, rate/rank, vessel assignments, etc.; surrendered previous licenses, letters of recommendation, examination questions and answers; statements of service history; and records of criminal convictions, if any.
  - A. Paper and Microfilm Copies of Records, 1967 and Prior and Associated Finding Aids. This includes records for Merchant Mariners born before 1930

**<u>DISPOSITION</u>**: **Permanent.** For records that are documented in MMLD (or equivalent) by January 1 of each year (starting January 1, 2013), transfer to the National Archives at St. Louis within 12 months

  - <u>DISPOSITION</u>: Temporary. Cut off at end of calendar year in which transferred to the National Archives in St. Louis Destroy 75 years after cutoff

D. Records for Merchant Mariners Licensed 1968-Present for whom the USCG does <u>not</u> issue a DD 214, Report of Separation from Military Service. This includes paper records, microfilm copies, and records in the Merchant Mariner Licensing and Documentation system (MMLD) or equivalent MMLD maintains information on merchant mariners with a Coast Guard license or merchant mariner's document in the maritime community, e.g., officers, staff officers, operators, and documented crew members. The system includes a merchant mariner's name, address, social security number, reference number, citizenship, telephone number, identifying characteristics, license or document activities, physical health information, and examination information

**<u>DISPOSITION</u>**: Temporary. Cut off at end of calendar year in which credentialing is complete. Destroy 75 years after cutoff

The system includes a merchant mariner's name, address, social security number, reference number, citizenship, telephone number, identifying characteristics, license or document activities, physical health information, and examination information

**DISPOSITION: Permanent.** Cut off at end of calendar year in which DD 214 is issued Transfer to the National Archives at St. Louis within 12 months.
