Under Vehicle Inspection System (UVIS)

Description The United States Secret Service is mandated by Title 18, United States Code section 3056 to protect the President, the Vice President, their immediate families, former Presidents, national leaders, visiting foreign heads of state, major Presidential and Vice Presidential candidates, and designated National Special Security Events Members of the United States Secret Service Uniformed Division are assigned to protect the White House and grounds, any building in which Presidential offices are located, the Treasury Building and grounds, the temporary official residence of the Vice President and grounds, and other venues as specified in Title 18 section 3056A of the United States Code, or as the President may direct on a by-case basis

In order to provide this protection the Secret Service may inspect vehicles entering its secured facilities using an Under Vehicle Inspection System (UVIS) While it is possible to conduct searches of vehicles' undercarriage with other tools such as hand held mirrors, the use of a camera-based system greatly increases the effectiveness and efficiency of that same search. Additionally, the use of a camera-based system allows the operators to effectively search a vehicle without stepping from a protected environment.

As vehicles pass over the system, cameras record the undercarriages of the subject vehicles. The resulting images are displayed on a workstation monitor, a Secret Service operator has the ability to select an area he or she would like to further inspect and zoom in on that particular area. The digital photographs of each inspected vehicle are stored as bitmap files using the unique letter and number combination from the license plate as the file name, these files are retained in the system for a maximum of 30 days, after which they are automatically deleted and overwritten. If a vehicle reenters the UVIS-equipped facility less than 30 days since its last inspection, the system will display the stored data for a side-by-side comparison of the current image, before overwriting the stored data with the new image. A maximum of only one image of a particular vehicle is stored in the system at any time.
