1.	<u>Climatological Fallout Maps, 1956-61.</u> (WNRC accessions 397-63A5015 and 397-63B5015)  Unarranged and rolled oversized paper and plastic overlays created by the Office of Civil Defense's Radiological Monitoring Division. The maps were claimed by the Defense Civil Preparedness Agency by direction of the Secretary of Defense, effective May 5, 1972. The maps and overlays detail the projected effects of wind currents, time, distance from blast, megatonnage of bombs and altitude of detonation upon the amount of radioactive fallout on major industrial and military centers in the United States.
