The Office for Bombing Prevention's National Capabilities Analysis Database (NCAD) gathers comprehensive bombing prevention data from State and local bomb squads, SWAT, public safety dive teams, and explosive detection canine teams with the purpose of assessing their operational bombing prevention capabilities, measure progress toward bombing prevention-related national preparedness goals, as well as provide real-time reports on response assets, vulnerabilities, and response capabilities within given jurisdictions throughout the United States

The task-based methodology measures readiness, equipment, training, and assets required for effective response to improvised explosive device (IED) threats This information, integrated in the NCAD database, provides a snapshot of national IED preparedness to properly allocate resources and enhance capabilities
