Form N-647 primarily serves as a roster of candidates for the Oath of Allegiance Ceremony. In judicial ceremonies, the N-647 certified to the court that the applicant had been determined by USCIS to be eligible for admission to United States citizenship upon taking the requisite oath of allegiance and renunciation in a public ceremony. The N-647 is prepared by USCIS and is used as a list to update the Computer-Linked Application Information Management System 4 (CLAIMS 4) to reflect naturalization of an applicant.

Form information includes, but is not limited to: Date of Naturalization, Alien Registration Number (A-Number), Alien Name, and Naturalization Certificate Number.

This schedule covers USCIS (USCIS & Legacy INS) Forms/
Documents/Lists regardless of creation date and document title that are used for functions similar to the N-647.
