Additional Schedule Information	Under section 312(a)(1) of the Immigration and Nationality Act ("the Act"), 8 U.S.C. 1423(a)(1), most applicants seeking to naturalize must demonstrate an understanding of the English language including an ability to speak, read, and write words in ordinary usage (English Language requirements). Additionally, under section 312(a)(2) of the Act, 8 U.S.C. 1423(a)(2), most applicants seeking to naturalize must demonstrate a knowledge and understanding of the fundamentals of U.S. history and of the principles and form of government in the United States (Civics requirements). Under 8 CFR 312.1(c) and 312.2(c), an applicant for naturalization may satisfy these requirements by passing an examination (naturalization test). Certain applicants may be exempt from the English Language requirements and Civics requirements if they either meet specific age and time as LPR thresholds, or if they cannot comply with the English Language requirements or the Civics requirements, or both, because of a physical or developmental disability or mental impairment. See section 312 of the Act, 8 U.S.C. 1422.

In 1997, the U.S. Commission on Immigration Reform (the Commission) recommended that the former Immigration and Naturalization Service (INS) standardize the naturalization testing process. The Commission recommended that the naturalization tests be revised to better determine if applicants have a meaningful knowledge of U.S. history and government and can communicate in English. Also in 1997, the Department of Justice (DOJ) began to reengineer the naturalization process. For naturalization testing, DOJ determined that the former INS should develop a more uniform approach to testing, including standard and meaningful test content, standardized testing instruments and protocols, standard scoring, and standard levels of passing. The former INS began to redesign the testing process with a goal of developing a new process that would be uniform, fair, and meaningful. On December 26, 2000, INS issued Policy Memorandum No. 73: Standardization of Procedures for Testing Naturalization Applicants on English and Civics to guide the testing procedures for the English and civics components of the naturalization test and to announce plans to redesign the test. In 2003, USCIS began redesigning the current naturalization test, which was fully implemented in October 2009 and is the test currently administered to all naturalization applicants. At the time, USCIS only standardized the reading, writing, and civics tests. The English-speaking test was not standardized at the time.
