Unscheduled records of the Public Housing Administration (PHA), 1943 through 1956, located at the Washington National Records Center (WNRC).

1. **Accession Number 196-65A-0923**

Former Taxation Branch Records, 1943-1956

Contains select case files (two for each five year period) from the taxation branch documenting the PHA's role in the terminated War Emergency Housing Program and the terminated Defense Housing Program. The records pertain to the payment in lieu of taxes (PILOT) made to various taxing districts where the housing projects were located. The files include many standard PHA forms providing such information as inventory lists of project and dwelling units and data regarding the physical status of PHA lands and buildings. Through a small selection of case files, this accession documents the status of various PHA projects over time and provides useful information about public housing accommodations and specifications during the period. Arranged alphabetically by project location. Volume: 1 cubic foot.
