<u>Justification:</u> These records document the authorized transfer of funds to meet the

emergency housing needs of various localities within the United States as a result of increased military growth stemming from World War II, the Korean Conflict and the Cold War, in general. The correspondence contains original letters to the White House describing the inadequacy of housing in the area of growing military installations or planned new installations, thus capturing the housing status of these areas historically, as well as capturing the decision making process. The correspondence also includes Presidential authorization letters and financial allocation tables with the authentic presidential signatures.
