1.	Land Docket Files on Greentowns Housing Program project Greenbelt, Md-Sh-6 and Md-1811. Records cover the period 1933-1955. These 6 cubic feet of records are the last part of accession 196-59D-1339 (Boxes 3-8) left in the Washington National Records Center (location 10-36-48-7-5). These records were offered to the National Archives for permanent retention under NARA Job NC3-196-81-5 A (Attachment 1) but were not accepted. The 6-2-86 Center printout lists these records as unscheduled. Since HUD no longer needs these records, we request that they be destroyed immediately.		
2.	Legislative History Files, 1947-1958. These 5 cubic feet of records are stored in the Washington National Records Center (location 10-54-26-5-1) as accession 196-59A-1165. These records are listed on the 6-2-86 Center printout as unscheduled. Since the program office has approved the destruction of these records (Attachment 2), we request that they be destroyed immediately.		
3.	Defense Housing Land Records, 1951-1954. Accession 196-61A-0463 contains 1 cubic foot of these records, stored in the Washington National Records Center (location 10-39-01-1-3). Since the program office has approved the destruction of these records (Attachment 3), we request that they be destroyed immediately.
