Additional Schedule Information	<p>The Department of Justice (DOJ or Department) collects on court-ordered judgments, contractual agreements, and settlement agreements, on behalf of the Department of the Treasury and other Federal agencies and is responsible for collecting from debtors who have defaulted on their responsibility to repay their debts, as well as ensuring the timely collection of current judgments and settlements. Such debts arise from the numerous Federal programs where Federal agencies loan money directly or guarantee or ensure loans from private financial institutions. The Department also collects amounts due the United States from fees, leases, services, overpayments, civil penalties, and other similar sources. These debts are the result of either direct proceedings initiated by the Department or referred collections where the Department of Justice is conducting litigation and debt enforcement on behalf of other federal agencies.</p> <p>Debt Collection activities are performed in all 94 U.S. Attorneys' Offices (augmented by attorneys at Private Collection Firms); and in six Litigating Divisions focused on handling specialized civil litigation that result in collection actions. These Divisions include: Civil, Criminal, Tax, Civil Rights, Antitrust, and Environment and Natural Resources. The Debt Collection Management (DCM) Staff in the Justice Management Division (JMD) is responsible for collecting and maintaining the data coming in related to federal debt. DCM provides the operational, litigation support, policy and client support services, training, and reporting needed to facilitate the collection of debts owed to the United States Government.</p>

Records only pertain to the collection of funds based on a ruling. Records documenting the full case are maintained with the pertinent case's litigation case file.	
<p>These records are categorized into two sections:</p> <p class="list-item-l1">(1) Custodian Collector (DOJ)</p> <p class="list-item-l1">(2) Recipient agency that receives payments via Intra-Governmental Payment and Collection (PAC) transactions.</p> <p>Records may include relevant correspondence, worksheets, and officially prepared forms that documents a complete or incomplete payment record received and made on behalf of individual's or company or corporations' initiation through the expiration or conclusion, or final payment action has been completed and verified. Memorandums of understanding (MOUs), interagency agreements, service level agreements, fiscal agency agreements, fiscal agencies agreements, non-disclosure agreements may also be included in these files.</p> <p>Additionally, records from the National Central Intake Facility (consisting of referral packages that contain a Claims Collection Litigation Report (CCLR), a Certificate of Indebtedness (COI), credit data, etc.), the Debt Accounting Operations Group records (relating to the receipt, disbursement, accounting, and reporting of payments received from and on behalf of debtors whose debts are being collected by various components of the DOJ), and the Private Counsel Program records (who works with law firms contracted to collect debts owed to the Federal government), may also be included with the financial case records.</p>

Group Description	The Consolidated Debt Collection System, tracks records of civil and criminal debts collected by the Department of Justice. These debts are the result of either direct proceedings initiated by the Department or referred collections where the Department of Justice is conducting litigation and debt enforcement on behalf of other federal agencies. The system is primarily used to support and track collection activities and the resulting financial actions. The collection data is needed for requests from Department of Justice (DOJ) leadership, the office of Management and Budget (OMB), DOJ's Office of the Inspector General, Congressional inquiries, and component level requests.
Data collected includes (but is not limited to):

In this judgment there are several different monetary penalties including assessment, restitution (federal/non-federal), fine, and other penalties. The USAO files a lien to protect the United States interest. The criminal debt may be enforced for 20 years after release from incarceration, parole, or (in the case of a corporation or organization) verdict/ruling.

The USAO may enforce this judgment by filing a judgment lien, garnishment, writs of execution, or by including the debt on the Treasury Offset Program (TOP).
