1.	<p><b>DEPARTMENT OF JUSTICE, DUPLEX-NUMERIC CASE FILES: CLASS 199 - National Childhood Vaccine Injury Act of 1986.</b></p> <p>This classification covers the litigation of petitions for no-fault compensation filed in the U.S. Claims Court alleging injury or death attributable to vaccines enumerated in the National Childhood Vaccine Injury Act of 1986, as amended. Claims Court Special Masters review the petitions, which include certain affidavits, relevant medical records, reports, and evaluations. Review of Special Masters' decisions is possible before a Claims Court judge, and further appeal is available to the Court of Appeals for the Federal Circuit.</p> <p>Since the injuries alleged in this litigation occur during childhood, agreements reached can involve compensation arranged over the course of the petitioner's lifetime. Consequently, reference to materials in these case files may be legally necessary many years</p>
