Naturalizations conducted by INS personnel or their designated representatives at overseas military establishments for aliens serving in the US Army. The files include the Certificate of Naturalization, Petition for Naturalization, Preliminary Form for Petition for Naturalization, certificates of entry or arrival, and other forms; inter- and intra-agency correspondence and memoranda among INS, DOJ, the Federal Courts, and other agencies; and recommendation by the applicant's Commanding Officer. Cases with legal entry, nationality (i.e., enemy alien), or criminal problems may also contain extensive correspondence</p>

The bulk of the file is a State Department form, Application to Resume Citizenship . . . , for a US citizen residing abroad who voted either in an Italian election between 1946 and 1948, or in a Japanese election between 1945 and 1952. These forms are the result of Congressional statutes. The case files also include the Oath of Renunciation and Allegiance and the Certificate of Expatriation, and may include interagency correspondence and memoranda (DOS/DOJ/SCAP), form letters, and questionnaires. Other documents in this series are repatriation forms for individuals who served in a foreign military and for women requesting citizenship through the repatriation of their fathers.</p> <p>DISPOSITION: PERMANENT. 4.	<p><u>Repatriation Files, Series 129.</u> Box 602. 5 reels, early 1950s, plus 3 supplemental reels, ca. 1936-43. All 16-mm. Arranged by case number, in rough chronological order. Repatriation cases of native-born women who lost their citizenship through marriage to a foreign national. The files include DOS/DOJ correspondence and memoranda, Application for the Oath of Allegiance, the Oath of Allegiance, and Certification of Loss of Nationality. The cases may also include findings and other court documents; birth, baptismal, and marriage certificates; divorce papers; death certificates for the spouse; and requests for FBI checks. The supplemental reels are largely lists of people recommended for repatriation or scheduled to take the oath of allegiance in particular judicial districts, and applications for replacement of lost papers.</p> <p>DISPOSITION: PERMANENT.
