	<p><u>United States Citizen's Identification/Border Crossing Cards</u></p> <p>Identification cards issued by Immigration inspectors at various ports of entry to American citizens and American citizens of Mexican descent living in towns adjacent to the border or on both sides of the international line, who had occasion to frequently cross and recross the border for legitimate pursuits; and could submit the best obtainable proof of his/her American citizenship. In the case of the Mexican Americans, the cards alleviated delays in their entering the United States because of their foreign appearance. These cards were confined to the port of use, unless it was established that the applicant had occasion to enter the United States from time to time through other ports of entry. If this was the case, an unrestricted card was issued and was honored by other ports.
