1.	<b><u>Priority Automated Commuter Entry System (PACES)</u></b>  PACES consists of:  (a) hard copy application forms, such as the Form I-823, Application--Participation in a Dedicated Commuter Lane Program; and  (b) a PC-driven computer system to record information furnished on the application form.  The hard copy and computer records are located at various ports of entry along the United States borders with both Canada and Mexico.  Information in the hardcopy/computer system is used to adjudicate applications to travel in commuter lanes established at certain land border entry points into the United States. The lanes were established to reduce border delays by allowing low-risk frequent border crossers, who have been pre-screened and pre-authorized, to travel across the border subject only to random border inspections.  PACES contains application data such as full name, place and date of birth, sex, address, telephone number, country of citizenship, alien registration number (if applicable), drivers license number and issuing state or province.

The application also includes such information as the frequency of border crossings, and the most frequent reason for crossing the border, together with an indication from applicant as to whether he or she has been convicted of any violation of law.</p> <p>In addition, the file may indicate that:</p> <p>(a) through an independent check of other law enforcement agency systems, INS determined that the applicant had been convicted of a specific violation(s) of law (a finding which could prompt denial of the application); or</p> <p>(b) through a random border inspection, INS identified a specific violation(s) of law which provided cause to remove the individual from the program.</p> <p>Finally, the file contains correspondence to the applicants indicating the disposition of their applications.</p> <p><b>Retention/Disposition:</b> (a) <del>Maintain</del> <sup>Destroy</sup> all records for three years after the dedicated commuter lane permit expires or for three years after the denial of an application or removal of an individual from the program.
