	<p align="center">CREW LISTS</p> <p>Form I-418, Crew List (8 CFR 251.1(a)), and associated forms listed below, are presented by the master or agent to document crewman arrival by water at any port within the United States from any place outside the United States. The purpose of the Crew List is to provide a complete list containing the names of all aliens employed on such vessel, the positions they hold in the crew, when and where they were shipped or engaged, and those to be lawfully paid off or discharged in the port of arrival. Before departure of any vessel from any port in the United States, the owner, agent, consignee, master or commanding officer, shall deliver to an immigration officer at that port a list containing the names of all alien employees who were not employed at the time of the arrival at that port but who will leave the port at the time of the departure of the vessel and the names of those, if any, who have been paid off, discharged, or who have deserted or landed at that port.</p> <p>The records are arranged alphabetically by port and then in chronological order.</p>	II-NNA-1631
