Implementation of Contract Labor Files 1946 - 1955

The files are copies of correspondence pertaining to the importation of foreign contract labor by individual companies. The correspondence includes memoranda on the investigation of the importation applications, the posting, payment, and default of bonds, lists of laborers, verifications of nationality, and notifications of work termination and the deportation of laborers. The contents indirectly indicate the use and originating point of the labor force and are administrative in nature, documenting the mechanics of importing and maintaining surveillance on the actions and location of the recruited workforce as they relate to the responsibilities of the hiring company and the I&NS. details of the individual use of laborers or the methods of recruitment are indicated. No demographic data, of an economic, political or sociological nature is included. Finally, no indications of policy, organization, or implementation of the contract labor program exists in these files.

The files were maintained from 1946-1955 by the Miami District Director of the Immigration and Naturalization Service. They are kept in numerical order, with each company having a designation (i.e. 6500-1), for all dealings on importation, and the files are maintained in numerical sequence by office (i.e., Atlanta, Dallas, Miami, New Orleans, and San Juan). The material in each file varies greatly in both the amount and number of inclusions of the types noted above.
