CRIMINAL INVESTIGATION FILES- CATEGORY 100 PROHIBITED ACT</b>  <b>These files relate to the serious crimes such as: inmate fights, assaults, escapes, stealing, destruction of government property, sexual offenses, setting up fires, or other disruptions to the security of the institution, that can occur at a Bureau of Prisons facility. Files consist of incident reports, medical reports, photographs, videotapes, official narratives, Form 583 (Use of Force Report), and Form 586 (After Action Review).</b>  <b>Note: The Bureau of Prisons will bring any historically significant case files to NARA's attention for appraisal on a case-by-case basis. Maintained at each facility and arranged by incident category and thereunder chronologically. Accumulation: approx. 1-2 cu. ft. per year</b>  <b>Retention: Temporary.</b> <b>Guidance: Cut off files at the end of the calendar year.
