Background: The Budget Execution Branch is responsible for planning and controlling the budget process beginning with the enactment of the appropriations and through the obligation and expenditure of resources. This branch oversees the Funds Control System (FCS), used to allocate and monitor the individual and collective acquisitions of all cost centers throughout the agency.

1. **Funds Control System - DATA** - This eRecord system consists of a web-based application using DB2 RDBMS and mainframe resources to store budget allocation and spending transactions by individual cost center assignment. The information stored consist of fielded data including cost center number, duty station, cost center manager, funding allocation and individual purchase transactions among other related fields
