Files include all documentation from application to settlement.

a. Czechoslovakian Claims Program (Second)

On February 25, 1983, the commission inaugurated a program (P.L. 97-127, the Czechoslovakian Claims Settlement Act of 1981), involving claims against the government of Czechoslovakia based upon losses between August 8, 1958, and February 2, 1982, resulting from the nationalization or other taking of property including any rights or interests owned therein. This program was completed on February 25, 1985.
