	<b>CRS Information System (CRSIS)</b>  CRS was created by the Civil Rights Act of 1964, and is the only Federal agency dedicated to preventing and resolving racial and ethnic tensions, incidents, and civil disorders, and it assists State and local units of government, private and public organizations, and community groups in restoring community racial stability and harmony.  CRSIS provides the Department of Justice (DOJ) a tool to assist communities and the people within the ability to prevent and/or resolve issues relating to discriminatory practices. **Department of Justice, Community Relations Service (CRS): CRS Information System (CRSIS)**

**1. ~~Inputs~~**

CRSIS data is manually inputted by CRS users. Contact information for Congressional Notification is received as an email attachment text file.

Disposition: Maintain with appropriate case file.

**2. Master File**

Each case begins with an "Alert"; followed by Deployment Notification, Assessment Report, Resolution, and Closure Report.

**a. Case Reporting**

The CRSIS database contains one record for each case. The major data fields include: Case Number, Alert Date, Report Author, Alert Source, Initial Tension, Title, Staff, Hours, Region, Organization, Location, Race, Issues, Alert Assessment, Resolution and Closure Report questions.

Disposition: PERMANENT, cut off when case is closed. Transfer to NARA in five year blocks 15 years after cutoff.

**b. Notifications**

Deployment Notifications (DN) are created to notify Congress when conciliators deploy to affected areas. The major data fields are CRSIS Case Title, Case Number, Date of Deployment, and Conciliator. Also included are assessment report(s) which detail the services preformed by the CRS conciliator to include mediation, technical assistance, training, etc.

Disposition: PERMANENT, cut off when case is closed. Transfer to NARA in five year blocks 15 years after cutoff.
