Background Information

System Title: Automated National Instant Criminal Background Check System Referral Application (ANR - ATF NICS):

The Gun Control Act of 1968 (GCA), Public Law 90-618, established rules and regulations for persons engaged in the business of buying and selling firearms (Federal Firearms Licensees or FFLs). The GCA also identified nine categories of persons prohibited from possessing firearms. The Brady Act of 1993 requires a three-day waiting period and background check through the National Instant Criminal Background Check System (NICS), or a State agency, prior to the transfer of a firearm from a FFL to a non-licensee. While the Federal Bureau of Investigation (FBI) or State agencies perform the NICS record checks, ATF analyzes NICS denials, and investigates and enforces Brady Act violations, including the actual or attempted acquisition of a firearm by a prohibited person. The FBI electronically transmits both delayed denials (made after the waiting period) and standard denials (made within the waiting period) daily to the ATF Denial Enforcement and NICS Intelligence Branch. ANR - ATF NICS Referral Application accepts the data electronically referred by FBI on NICS denials to enable ATF specialists to initiate investigations on individuals who have attempted to purchase a firearm but were denied after the background check.

When Investigative Systems Operation Specialists (ISOSs) determine that a denial should be investigated they enter the denial status in ANR as either Refer-Delayed or Refer-Standard. A case is then automatically created via a system link with NFORCE, the ATF's electronic case management system, and the case is transferred to

the NICS coordinator at the appropriate ATF field division office for appropriate investigative action.

Disposition of system output is governed by the Records Control Schedule for NFORCE case management system. (N1-436-03-005, Item 1) (Permanent) and is not included in this request.

This system replaces a manual ATF NICS Referral Files scheduled as N1-436-08-002, which is now obsolete.
