Records Retention Schedule National Drug Intelligence Center Synthetic Drug Early Warning and Response System (SENTRY)

Sentry is an internet-based collection and dissemination system designed to help identify new, primarily synthetic drug-related behaviors at an early stage, evaluate their likely importance, track their development, and share this data with authorized users in a real-time environment SENTRY is accessible at www.sentry.usdoj.gov or via the Internet site

Through the SENTRY web site, authorized users provide information on new or unusual synthetic drug-related activity via an electronic submission form. They also receive email notices when watches and warnings are posted. View previously reported submissions from all authorized users through the geographic information system (GIS) capabilities, link to partner agencies, and search/receive NDIC products.

1. Master File

Primary information is displayed in textual format on the internet, which can be searched by a variety of criteria, and as an array on a GIS map. Additional information is contained in Watches and Warnings.

Disposition: Temporary Destroy/Delete maps when 10 years old

2. System Outputs

NDIC uses the information obtained through SENTRY, combines it with additional information, and produces and disseminates Drug Alert Watch and Drug Alert Warning reports to the multiple levels of federal, state and local registered users

a Drug Alert Watch

Disposition: Temporary Destroy/Delete when 5 years old (GRS 20/5)

b-Drug Alert Warning

Disposition: Temporary Destroy/Delete when 10 years old (GRS 20/5)
