1. Statistical Fatal Cards for Fatal Cases under FECA and its extension, c.1933-1965. The records are arranged roughly as follows: by act, thereunder by year, and sometimes, thereunder by case number.

These records document the death of civilian Federal employees due to injuries sustained while performing their official duties. They contain information on the place and nature of employment, circumstances of death, and compensation awarded.

2. Fatal Dependency Cards, 1959-1968. Arranged chronologically, thereunder by act.

The BEC Form 76 includes the following information: name of dependant, case number, date case approved, monthly award, total value, relationship of dependant to the deceased, and who the deceased worked for.

3. Terminated Files of Insurance Carriers, 1927-1971. Arranged by insurance companies and self-insurers, thereunder by act filed under, thereunder alphabetically by company.

The records include correspondence, forms, and publications regarding Bureau of Employees Compensation authorization for insurance companies reimbursement under various workers' compensation acts including: the Longshoremens' and Harbor workers' Act, the Defense Base Act, the Nonappropriated Funds Act, the Outer Continental Shelf Lands Act, and the District of Columbia Compensation Act. Many of the records originated with the US Employees' Compensation Commission and were transferred to the BEC.

The computer printouts contain the name of the injured claimant, and code numbers denoting the following: district, department, state, occupation, age, nature, location, extent, case, sex, and status. There is no key to the coding system included with the records.
