## **Summary.**

This action establishes a new Office of the Secretary records disposition schedule entitled:

“3151 Electronic FOIA Tracking System.”

## **Reason for submission:**

- (1) This action provides for the disposition of electronic records maintained in the Office of the Chief Information Office, in compliance with recent Office of Management and Budget (OMB) requirements for the scheduling of electronic records.
- (2) This action incorporates the numbering pattern for the Office of the Secretary’s most current records manual.

**3151 Electronic FOIA Tracking System (EFTS).** An administrative system used by the Department of the Interior's Freedom of Information Act offices to electronically store, track, and manage information related to FOIA and Privacy Act requests and responses. The data from the system is also used for generating the annual FOIA activity report to the Department of Justice.

The schedule also covers the FOIAXpress tracking system used by the Office of Inspector General.

Disposition: Temporary. Cut off at end of fiscal year in which the request is completed and/or closed. Destroy/delete 6 years after the cut-off date
