1.	<p>Cartographic maps and other records transferred to the CRGIS Facility from the Civil War Sites Advisory Commission.</p> <p>These records consist of the original U.S. Geological Survey (USGS) Quadrant 22x28 base maps for data gathered by the Commission's historians and field surveyors, showing historic and modern features and troop positions for 384 principal Civil War battlefield sites. The base maps are used to accurately locate geographically the Commission's 384 principal sites in a GIS database that can be updated on a regular basis. The CRGIS Facility has been working in conjunction with the Commission staff to map and digitize the 384 principal sites. The CRGIS Facility will continue to carry on the the digitizing, mapping and GIS work after the Commission's end date (October 10, 1993). Selected sites will be "ground-truthed" using a Global Positioning System (GPS). The information gathered from the application of this technology will be used to support the Commission's initial findings and will be available to Federal, state and local agencies for land-use planning in conjunction with battlefield preservation.</p>
