A portion of the items are listed in the <u>Subject Catalog of the Special Panama Collection of the Canal Zone Library-Museum</u> (G.K. Hall: Boston). Although not all of the maps and plans are Federal records, each item has been captured on 105 mm microfilm by the Canal Commission.
