Documents on the Liberty Loan Committees and files on the use of coercion to induce subscriptions with numerous statements showing amounts credited by the Federal Reserve Banks for principal and accrued interest on 1st, 2nd, 3rd, and 4th Liberty Loans are included.</p> <p>Additional records on the Bureau of Engraving and Printing audits from 1937-48, processing documents and files on false claims, and the negotiability of corporation securities during 1921-31, to include records on protests by investors and holders on "Redemption in Gold" referencing the gold clause of 1937-52, along with the files on foreign loan repayment purchases from 1941-51 are included.</p> <p>In addition, files and reports include information on the "War Finance Corporation" on market transactions from 1917-19 and their interest, including payment coupons that matured.</p>

(1992)</p> <p>Circulation of and Historical Value of U.S. and Foreign Currencies (Series "K" Currency) WNRC Accession 53-87-101</p> <p>Summary history of U.S. money from 1931-37, various circulation statements of U.S. money showing the amount and kinds of money in circulation during this period are included in these records. Many types of certificates, notes, currency, old issues of currency and files on the Currency Designs Committee from 1925 are also included.</p> <p>Correspondence on the amount of each class of old series currency now outstanding (1961-66) which has been declared irretrievably lost or destroyed and will never be presented for redemption. Records on confidential instructions provided in 1920 with respect to exchanges, replacement, shipment of old size currency, and redemption of U.S. paper currency at the Treasurer's reserve stock at Federal Reserve Banks.</p> <p>Files on the balances at Treasury by denominations from 1927-51 for U.S. notes, gold and silver certificates on currency in reserve, in addition to the origin of the dollar and the value of currency are included.</p> <p>The values of foreign monies, historical legislation between 1923-38, the value of confederate monies in 1938 and numerous correspondence from citizens of the U.S. on the value of confederate and continental money during 1934-37, including press clippings from 1927-31 on the reduction in size of currency and press statements from 1927-29 on the adoption of reduced size currency, also correspondence to the U.S. Secret Service on specimens of counterfeit fractional currency and old issue notes dating around 1867 for comparison purposes, and specimens dated from 1913-28 are included.</p>

These files include contracts with paper makers, and document of experimentation during the making and testing of distinctive paper to determine such qualities as sizes, colors, thickness, and types of materials to be used.</p>

Included are samples of various matrixes on experiments and proposed improvements on paper currency and securities, authorization files on postage stamp stereotype plates for U.S. Post Offices, historical data on paper treatment companies and bodies that were assigned custody of dies, rolls plates from 1911-1913 to print documents from other Treasury bureaus. Shipment methods and methods for accounting for distinctive paper are also documented in these files.

Statistics on various notes, series and percentages from 1933-46, and administrative documentation of Departmental circulars, legislations, loan bonds, certificates of stock, and numerous acts from 1916-45, bonds from 1935-64, and press statements are included. Files on investment purchases, expense accounts and memoranda responding to inquiries from investors, holders and numerous organizations, agencies, mortgage enterprises, and documentation of their function are included.~~
