	<b>Award Tracking System (ATS)</b>  <b>Background:</b> The CDFI Fund uses four data collection systems to administer and monitor the New Market Tax Credit Program (NMTC) program. The NMTC permits taxpayers to receive a credit against Federal income taxes for making qualified equity investments in designated Community Development Entities (CDEs). Substantially all of the qualified equity investment must in turn be used by the CDE to provide investments in low-income communities. The Award Tracking System is one of the four data collection systems. It enables the tracking of allocated credits and reporting information about investors.  <b>Description:</b> The Award Tracking System is the primary system that CDFI Fund uses to monitor Qualified Equity Investments (QEIs) that have been made and track CDEs (allocates), suballocates, and investors in the CDEs. The ATS contain information reported by the CDEs on the type of QEI that is made in the CDE, the amount of the investment, the CDE that received the investment, whether the CDE that initially received the allocation transferred the allocation to a suballocatee, and how much of the allocation was transferred.
