	<b>CDFI Compliance and Monitoring System (CCMS)</b>  <b>Background:</b> The CDFI Compliance and Monitoring System (CCMS) uses the CDFI reporting data currently entered into the Community Investment Impact System (CIIS) and data received in paper format. CIIS developed by the CDFI Fund is the nation's first system to collect standardized institution and transaction level data from CDFI Program awardees and New Market Tax Credit (NMTC) Program allocates. The New Markets Tax Credit (NMTC) Program permits taxpayers to receive a credit against Federal income taxes for making qualified equity investments in designated Community Development Entities (CDEs).  The new system will perform compliance checks on that data by comparing it to the performance goals and measures listed in the Assistance Agreement. The Assistance Agreement contains standard terms and conditions for all awardees/allocates as well as terms and conditions that are specific to each awardee/allocatee.  The system will enable Compliance staff to impose sanctions or remedies on awardees that are determined to be noncompliant. The system will also

Inputs:</b> Data is received from CIIS, Certification and Compliance Monitoring and Evaluation (CME) business areas.</del></p> <p><b>Disposition:</b> TEMPORARY. Destroy after successful entry and verification.</p> <p><b>B. System Data:</b> CCMS will integrate seamlessly with CIIS, AAS 2.0 and the Certification System and will be comprised of data related to reporting and certification.</p> <p><b>Disposition:</b> TEMPORARY. Destroy 10 years upon close of award.</p> <p><b>C. Outputs:</b> The Compliance Monitoring Evaluation (CME) and Certification personnel shall use the data to formulate reports.</p> <p><b>Disposition:</b> TEMPORARY. Destroy after 6 years or when no longer needed for operational purposes, whichever is later.</p> <p><b>D. System Documentation:</b> Codebooks, records layout, user guide, and other related materials.</p> <p><b>Disposition:</b> Temporary.
