The Special Assistant served as the principal adviser to the Secretary on law enforcement matters, and he supervised the United States Secret Service, the Office of Law Enforcement Coordination, as well as the Treasury Enforcement School. He also formulated law enforcement policies and programs for all Treasury enforcement activities, including those of the Bureaus of Customs and the Internal Revenue Service. This office was the predecessor of (replaced by) the Office of the Assistant Secretary (Enforcement, Operations, Tariff, and Trade Affairs).</p>
