Comprehensive Records Control Schedule for all records created by the Emergency Loan Guarantee Board (ELGB).

The ELGB was established by the Emergency Loan Guarantee Act of 1971 (PL 92-70) to administer the government's guarantee of private bank debt to the Lockheed Corporation. The Board was comprised of the Secretary of the Treasury as Chairman, and the Chairmen of the Federal Reserve Board of Governors and the Securities and Exchange Commission. The Board formally terminated its operations as of January 31, 1977, upon satisfaction of its statutory authority and responsibilities. It transferred permanent authority and responsibility for all residual matters related to its guarantee program to the General Counsel of the Department of the Treasury.
