Background Information

Banknote Equipment Manufacturers (BEM) produce equipment that handles banknotes for commercial purposes. There are a diverse group of companies using banknote equipment in-commerce for a variety of clients including:

- Gaming and Amusement Sectors
- Commercial Banks
- · Cash-in-transit
- Parking
- Retail
- Central Banks

The Bureau of Engraving and Printing's (BEP) BEM Support Program provides BEMs an opportunity to receive and evaluate U.S. currency notes samples prior to issuance for the purpose of updating their equipment to denominate and/or authenticate genuine U.S. currency notes. The BEM Support Program provides services for Currency Reader Manufacturers (CRM) as well.

The BEP's BEM Support Program, the Board of Governors of the Federal Reserve System-Division of Reserve Bank Operations and Payment Systems, and the Bank of Richmond's Currency Technology Office (CTO) are members of the United States Cash Machine Group (USCMG). USCMG serves as an interactive, interagency forum to facilitate BEMs' ability to accept genuine U.S. currency notes or reject counterfeit notes. In addition, the USCMG assists the BEP's BEM Support Program's collective understanding of BEM technologies, and provides BEM industry knowledge into the banknote design process.
